the fine print

Each group account is required to appoint an internal administrator to serve as a liaison between the organization and LiiNCS, and to receive the annual group renewal invoice. The administrator is responsible for maintaining current membership records and arranging payment of invoices.

Membership within the group belongs to the organization and not the individual. Group administrators may make membership changes at any time during the year, and be invoiced for new members immediately. Group members are not contacted individually regarding renewing. Discounted group memberships are billed in one invoice annually and must be paid with a single check or credit card. Multiple forms of payment are not accepted.

All members within the group discount plan are enrolled at the Gold level (\$250 per year; discounted to \$150 per year for 2018 enrollees) only. Dues and fees are applicable for a full-year membership (12 months). Organizations are required to sign a minimum 3-year contract for group memberships.



group application form

Your organization's group administrator — the individual you select to serve as a liaison between LiiNCS and your company — fills out this application form and returns it to our membership coordinators at membership@liincs.org

Once we receive your application, a LiiNCS membership coordinator sends a confirmation form to each member of your group. The members use this form to select preferences for their membership. Each member is responsible for returning his or her form to the LiiNCS within 7 business days

A membership coordinator will also send an invoice for dues payment for the group administrator. Memberships will be activated upon receipt of cleared payment.
